

#### OSA IN THE COVID - 19 ERA



This has been an uncertain time in North Carolina and around the country. The Office of the State Auditor is no exception. Our goal has been 3-fold: 1) provide safe working environments for our employees and clients, 2) continue to protect the interests of taxpayers and provide objective information about the use, management, and reporting of state resources, and 3) make cost-saving adjustments to our agency budget as the state realizes significant revenue shortfalls.

The NC General Assembly passed the 2020 COVID-19 Recovery Act empowering OSA to conduct a preliminary financial audit and a final performance audit of the Coronavirus Relief Fund. This is an additional tool in our arsenal to protect your tax dollars. As large sums of money flow into our state to provide much-needed relief to families, small businesses, and local governments, we will be closely monitoring the use of these funds.

#### DOT CASH SPENDING PLAN



In November 2019, the NC General Assembly directed OSA to conduct a performance audit of the Department of Transportation (DOT). Some of the things we reviewed were adherence to budgets, cash management, controls and oversight of divisions, and timeliness of federal reimbursement requests and responses to federal requests for information or action.

In May 2020, OSA released the DOT Cash Spending Plan Performance Audit, which found that DOT exceeded its FY2019 Spending Plan by \$742 million (12.5%). The Spending Plan was not based on cost estimates of specific projects or scheduled DOT operations. Compliance with the spending plan was not enforced across divisions. #### STATEWIDE SINGLE AUDIT



The Statewide Single Audit is an audit of the federal funds NC receives each year, most in the form of grants such as Medicaid, Student Financial Aid, funds to build highways and bridges, and money for clean air and water.

NC spends more than \$20 billion annually in federal financial assistance under various federal The Single Audit uses a prescribed, risk-based approach to select certain programs annually to be audited. Auditors perform audit procedures to provide assurance to the federal government as well as taxpayers about the management and use of these federal funds. The results of the audit procedures are compiled into the Single Audit Report for the State of NC and submitted to the Federal Audit Clearinghouse. You can find the Single Audit Report here.

#### OSA INVESTIGATIONS



OSA consists of several divisions including the Investigative Division. This division opens investigations in response to allegations of fraud, waste, or abuse of taxpayer dollars. The findings of these investigations are often used by elected officials and policymakers to change management, accountability, and oversight functions of agencies that receive taxpayer funds. Recent investigations include:

In 2020, OSA has released impactful audit and investigative reports across all divisions—financial, information systems, investigative, and performance. These reports are essential for monitoring, policy development, cost savings, and holding your leaders accountable.

In the coming months we will conduct financial and performance audits of state agencies. We will audit the COVID-19 funds that flow into NC. And we will continue to investigate allegations of misuse of state resources. You've given me an assignment and I will continue to carry it out faithfully.

As the State realizes shortfalls in revenue due to COVID-19, I am considering cost-saving measures at OSA. Families have to tighten their belts when they experience a decrease in income; state agencies should do the same. My executive team and I are looking for ways to reduce our financial obligations, while continuing to provide the high level of monitoring and accountability you've come to expect from the Office of the State Auditor.

We will get through these tough times together, and be stronger on the other side.
