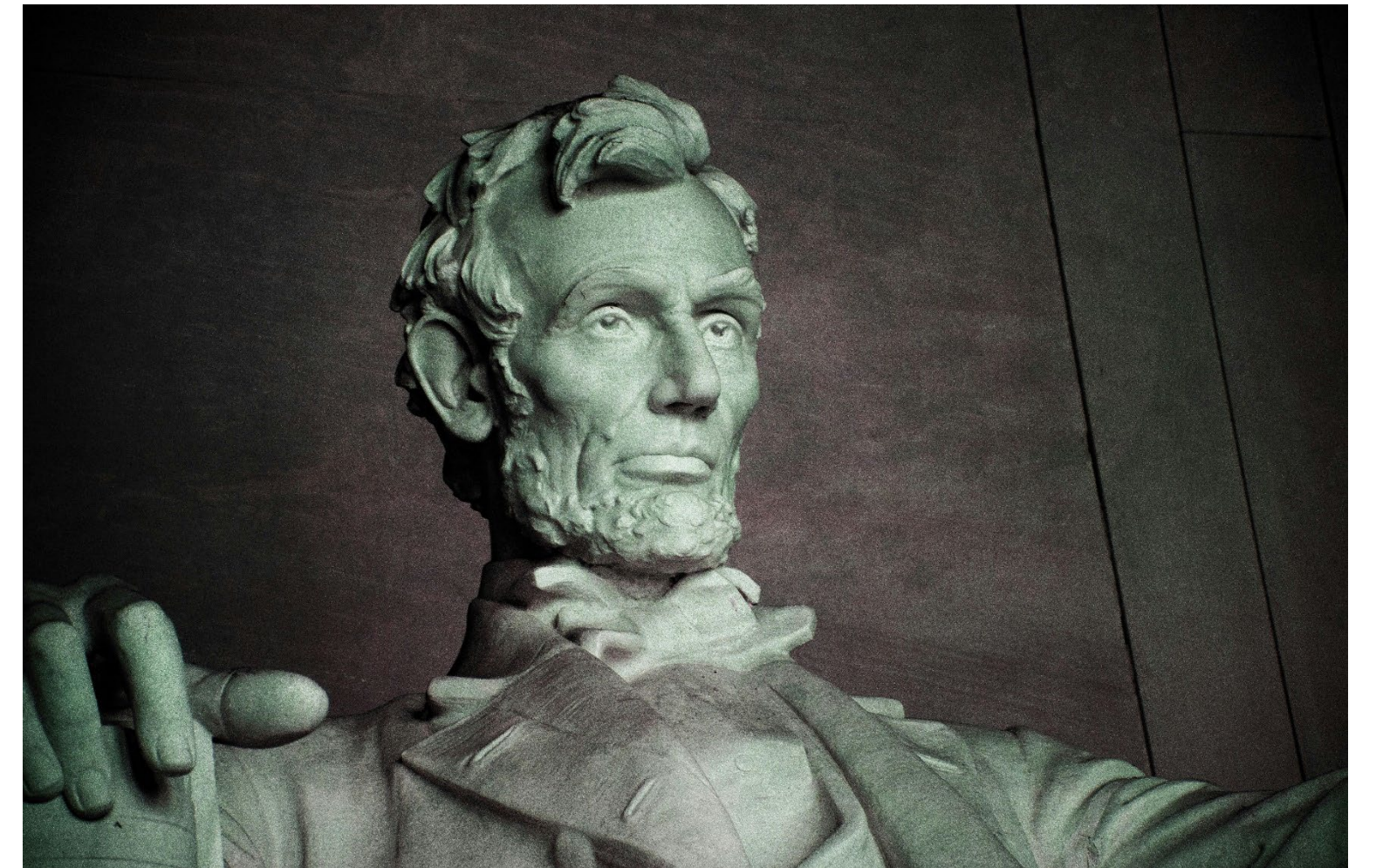

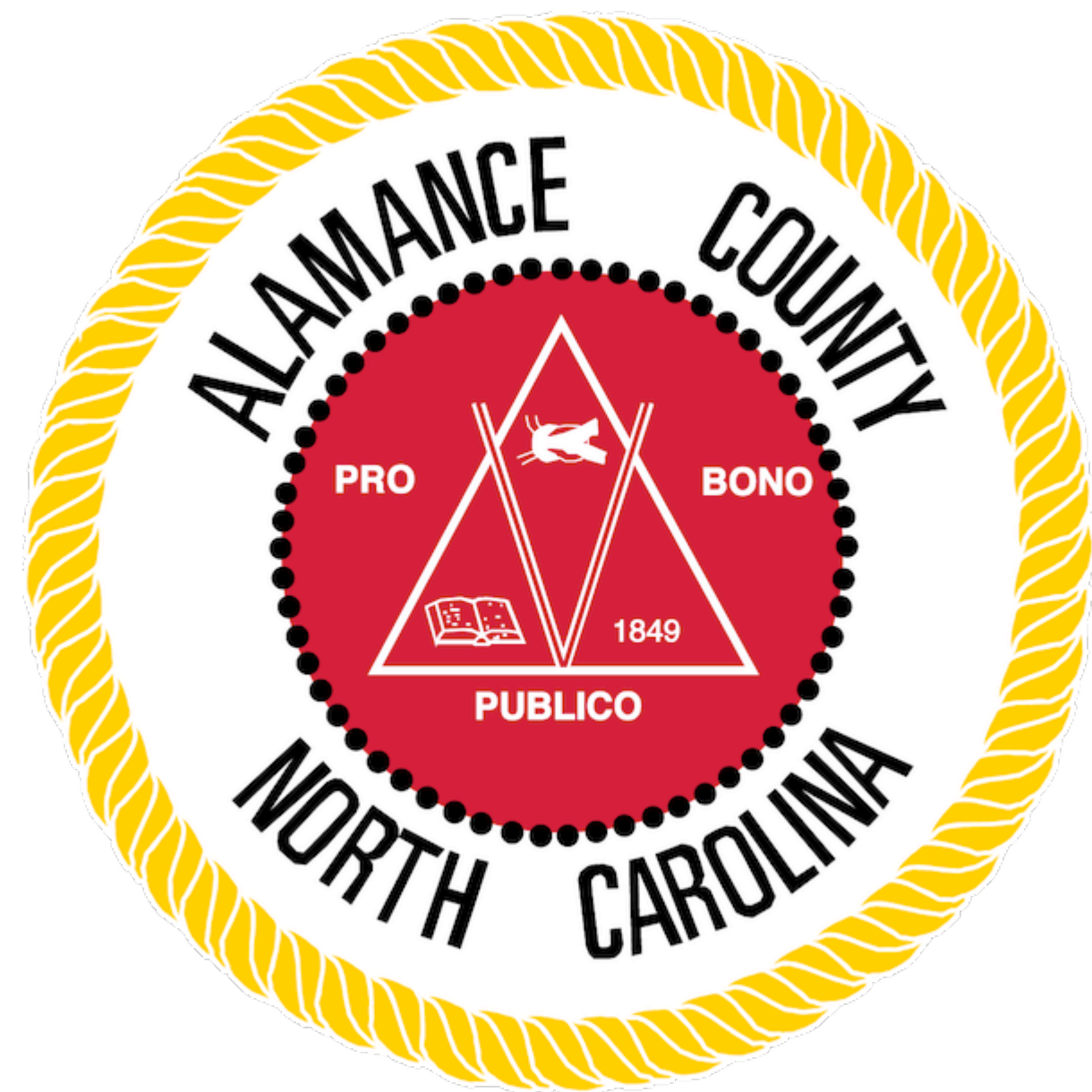

What unusual geological feature can be found at Pilot Mountain?

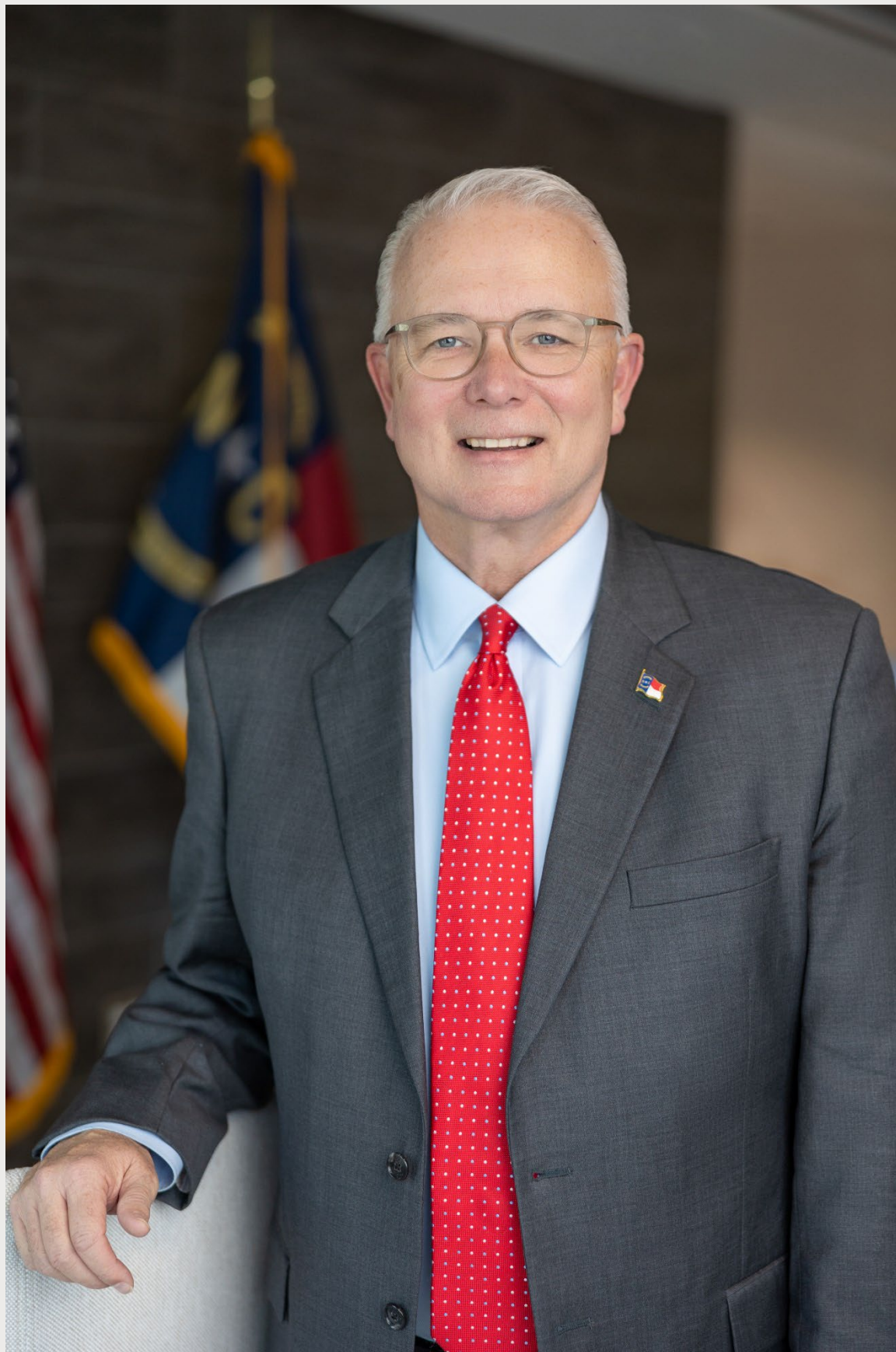
A quartzite monadnock rising abruptly from surrounding terrain



Rising more than 1,400 feet above the surrounding landscape, it consists of Big Pinnacle, a white quartzite monadnock with sheer rock walls and a rounded, vegetation-covered top, and Little Pinnacle, a lower section that is comprised of metamorphic rock not usually found in the region.

Geologists believe that the 200-foot-high Big Pinnacle was formed by the compression of sand from a beach that existed in western North Carolina approximately 1 billion years ago.

Dallas Woodhouse held a similar role at NBC-17 in Raleigh, where they covered similar stories for a couple of years before Mr. Boliek retired.

You are an appointee of State Auditor. Your actions, both official and non-official reflect on Auditor Boliek and OSA.

- Perform the role with integrity, accuracy and transparency.
- Enforce the law and NCSBE directives as written. Follow all NCSBE legal advice.
- Suggest improvements to election procedures as needed.
- Keep legislators, and county commissioners/officials informed and engaged.



What OSA can do for you:

- Provide guidance on Board functions, relations, and decisions.
- Assist in securing supplementary training for members and staff.
- Assist in relationship building conflict resolution with County officials, other board members, and concerned parties.
- Advocate for funding for county specific needs.
- Evaluate early voting plans and provide feedback to make sure all areas of your county have full access to early voting sites.
- Get answers to critical questions.
- Offer leadership advice.

- **Transparent, Accurate, Honest, Accountable Elections Process.**

Focus on building public trust and participation.

Verify, check and double check to review systems and process.

“Out of 7,763,502 eligible N.C. voters, 5,724,001 cast a ballot in the 2024 general election.

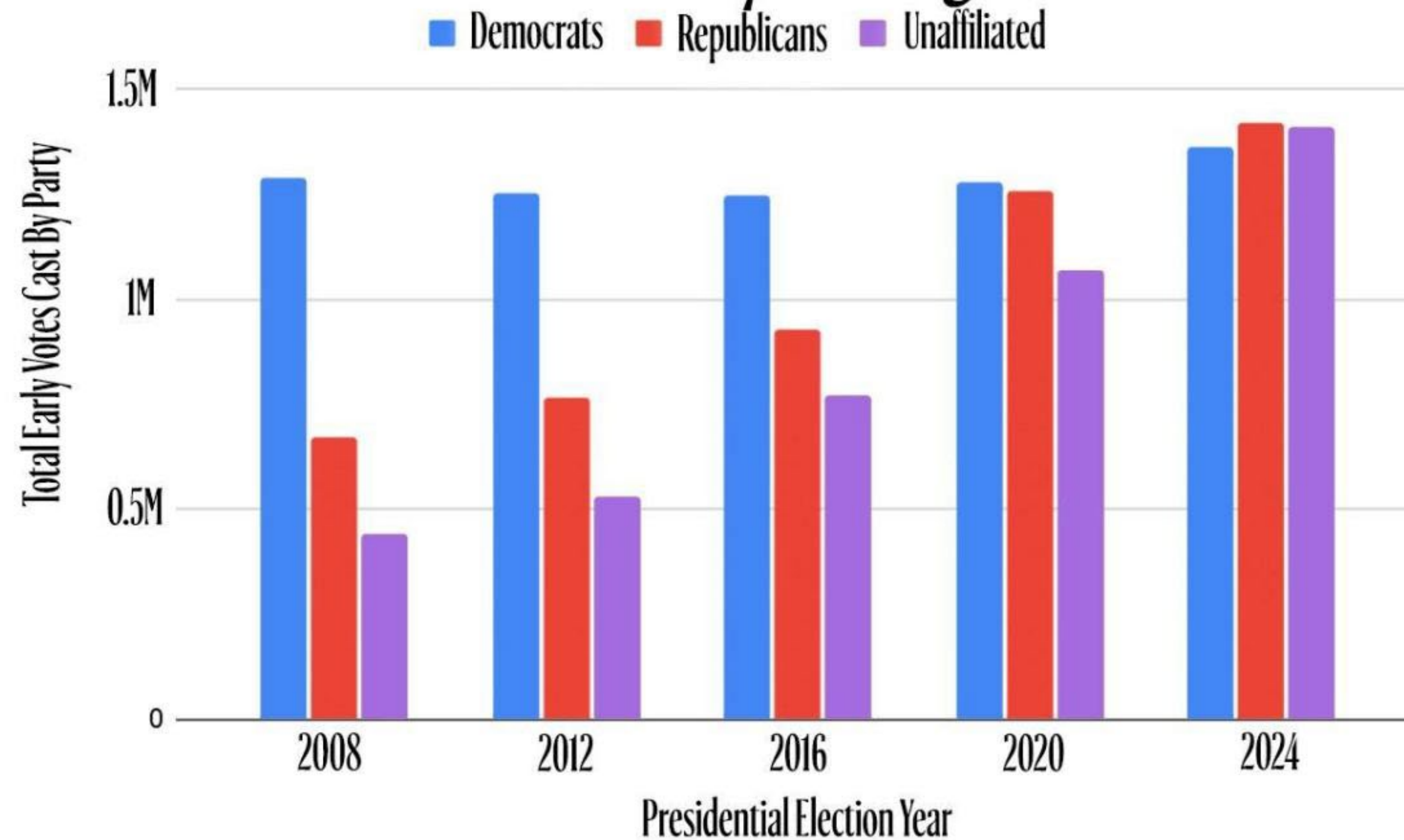
Voter turnout in North Carolina decreased from 75.35% in 2020 to 73.73% in 2024, despite a record number of [early votes](#) counted.

Importantly, though, 2020 represents North Carolina’s highest voter turnout rate at least since 1972 — 2008, 2012 and 2016 all hovered around 69%.”

Republicans Eclipsed Democrats in Early Voting



Voter turnout in North Carolina midterm elections has fluctuated. The 2018 midterm saw a higher turnout compared to 2014 even without a U.S. Senate campaign at the top of the ballot.

Turnout in 2022 was slightly lower than in 2018, at around 51% compared to 53%.



Emerging Issues in North Carolina Elections

Election Audits.

Numbered Memos-Administrative Code Review.

Replacement of SEIMS System. Advisory Committee.

Early voting flexibility in small counties.

Elections (NCSBE) Executive Director Sam Hayes has sent a second letter to NCDMV requesting the Social Security numbers of DMV customers who are also registered voters. The information would allow election officials to match voter records more precisely against other government databases, identify duplicate registrations, and verify voter eligibility.



Rules of the Road for Meetings



Effective Agenda Preparation

- Draft a clear agenda in advance.
Share with board members and the public before the meeting.
- Prioritize important topics.
Place critical items early in the agenda if possible.
- Include time estimates for each item or note for yourself appropriate time limits.
Keep the meeting on track and respects participants' time.
- Distribute supporting materials ahead of time.
Enables informed discussion and decision-making.



Agenda Discipline

- An agenda is the Chair's strongest tool for maintaining order.
- Follow the agenda unless the Board votes to amend it.
- Avoid surprise items — transparency builds trust.
- Stick to time limits to prevent meetings from becoming unmanageable.
- Conduct official business efficiently while ensuring public transparency.
- Protect the legal authority and integrity of the Board.
- Create a clear record for the public and for legal review.

Robert's Rules

- One issue at a time. One speaker at a time.
- Majority rules, minority rights are protected.
- Every motion must be clear and decided by vote
- No discussion occurs without a properly made motion.
- A motion requires a second before debate.
- Restate motions clearly before discussion and voting.
- Focus discussion strictly on the pending motion.
- Recognize speakers in turn.
- Limit repetition and off-topic remarks.
- Set reasonable time limits if debate becomes excessive.
- Remain firm, calm, and impartial.



Robert's Rules For Public Comment

- Public comment rules should be clearly stated at the start.
- Enforce time limits equally.
- Public comment is not debate with the Board.
- Maintain decorum while respecting public participation.
- Consider allowing written pre-comments.

Robert's Rules For Public Comment

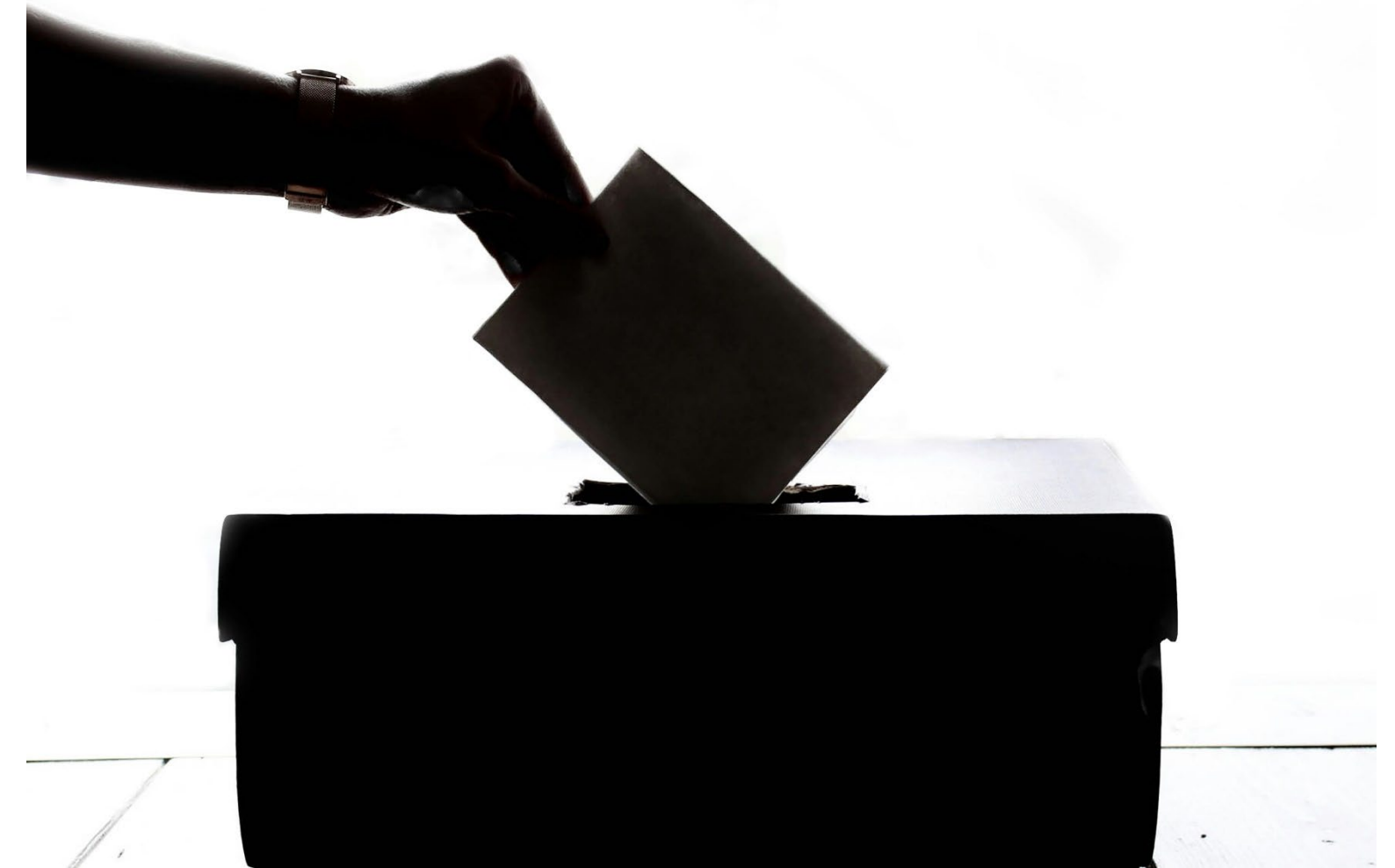
- Address disruptions immediately and professionally.
- Remind speakers of rules before escalating action.
- Use warnings, not arguments.
- If necessary, recess briefly to restore order.

Robert's Rules

- Clearly state the motion before the vote.
- Announce results clearly for the record.
- Ensure votes are accurately recorded.
- Consider brief recess if needed.
- **Avoid these pitfalls.**
 - Allowing debate without a motion.
 - Failing to restate motions before voting.
 - Engaging emotionally or personally in disputes.
 - Letting meetings drift without clear structure.



Robert's Rules

- Gently redirect speakers who stray off topic.
- Summarize discussion before moving to a vote.
- End meetings promptly once business is complete.
- Speak clearly and deliberately for the record.
- Avoid side conversations.
- Ensure all motions and votes are audible.
- Assume all actions may later be reviewed.

Robert's Rules

- Use Robert's Rules as a neutral authority.
- Pause or recess if emotions escalate.
- Seek NCSBE and/or OSA guidance on serious or recurring conflicts.
- Ensure fair treatment of all Board members.
- Maintain public confidence through professionalism.
- Lead with calm authority and respect for the rules.



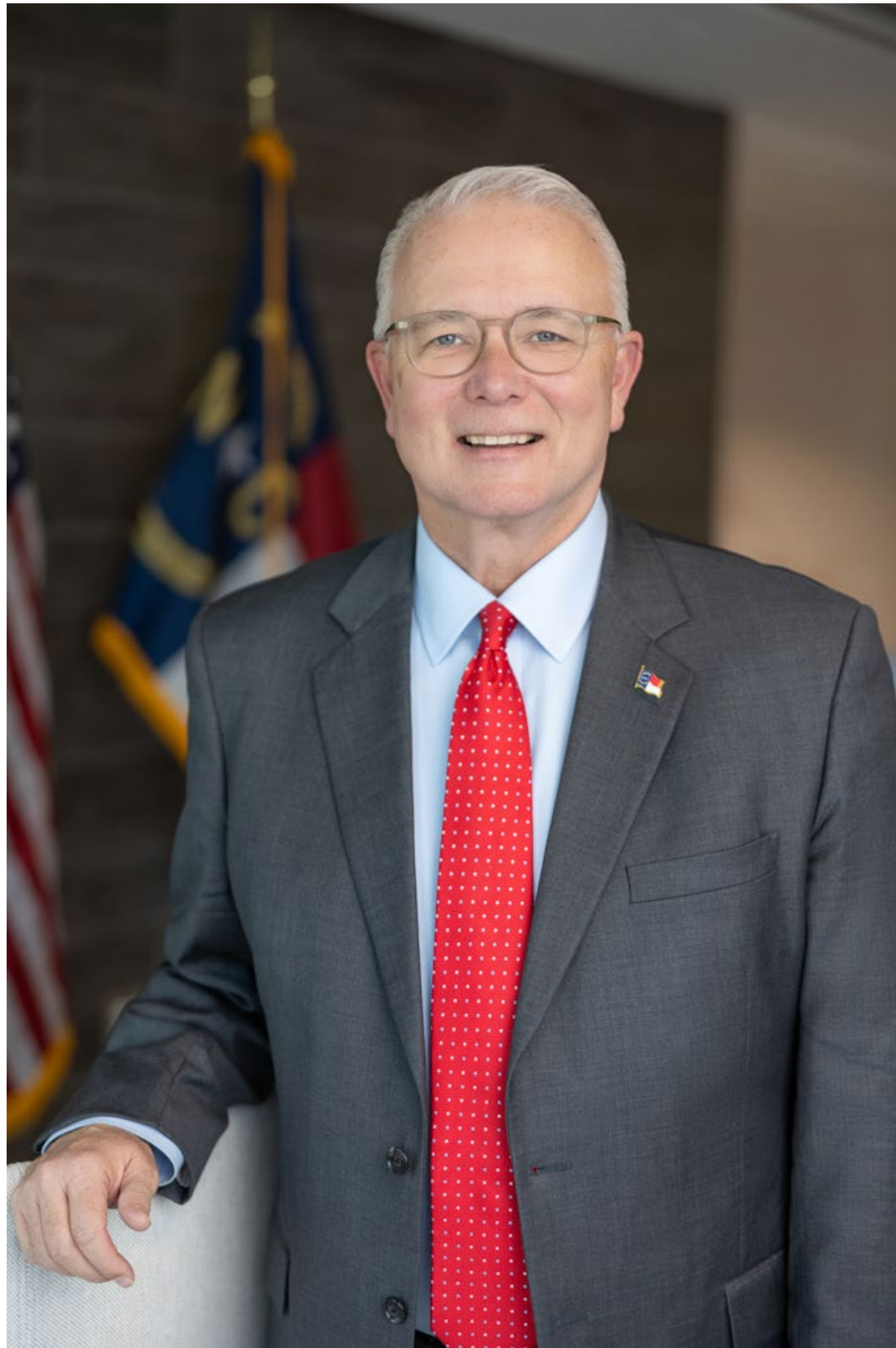
