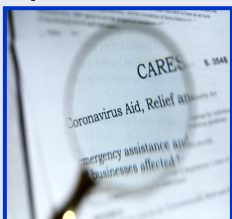
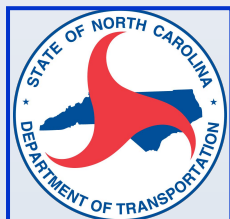


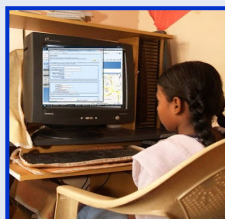

## OSA Focuses on CARES Act Funds

The clock is ticking for North Carolina agencies to spend the \$3.5 billion they received from the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The Office of the State Auditor (OSA) recently pivoted from routine audit work to begin a financial audit and a performance audit of the federal CARES Act moneys. OSA has initiated these audits "now" instead of waiting until the moneys are spent to tell the federal government and NC leadership of any failures. OSA is focusing on four agencies to ensure they have a plan, are implementing their plan, and are actually monitoring the spending to ensure these CARES Act moneys are accomplishing what the federal government and the NC General Assembly intended. The deadline to spend the money is December 30, 2020.



The four agencies and their major initiatives are:

1. Office of State Budget & Management - sending money to local governments and not-for-profits;
2. Department of Health and Human Services - COVID-19 response (testing, tracking and tracing);
3. Department of Public Instruction - bridging the gap for under-performing students, without access to broadband / internet services, trying to succeed in an online learning environment;
4. Department of Revenue - Extra Credit Grant Program (\$335 to families with qualifying children).

## DOT Salary Overspends

The General Assembly authorized a 2-year pilot program to run through June 30, 2020 that allowed the NC Department of Transportation (DOT) flexibility to adjust salaries for employees who voluntarily gave up their longevity and career status. Legislation authorized the DOT to use up to two percent of their payroll expense or \$19.6 million.



In July 2020, OSA released the DOT Salary Adjustments Performance Audit which found that the agency gave salary adjustments/raises to employees who did not waive career status or longevity pay. Additionally, the \$58.5 million spent on the raises exceeded the two percent limit.

Whether intentional or due to lack of appropriate due diligence, DOT overspent \$39 million on its salary adjustments, an overspend that will recur annually. Read more about these findings [here](#).

## NC DPI Virtual Public Schools Performance Audit

Based on a tip received by parents of a high school student taking an online honors history class, the OSA conducted a performance audit of the Department of Public Instruction (DPI) to determine if online classes were meeting required NC education standards. In a sample of 12 of the 132 courses offered, OSA found:



- 8 out of the 12 courses did not include all the course content required by NC education standards.
- 11 of the 12 courses were not challenging enough to meet guaranteed rigor standards: that students master learning objectives, engage in critical thinking, and retain what they learn.
- Teachers were not being evaluated consistently and in accordance with DPI policies and their mission to provide high-quality online courses and instruction.

## The Auditor's Findings



As we enter the final quarter of 2020, I am more determined than ever to keep tackling and exposing the misuse and mismanagement of your tax dollars.

North Carolina was sent approximately 4 billion dollars from the federal government to respond to the effects of coronavirus, and I am already preparing to give my first update to the General Assembly in just a few short weeks. Not surprisingly, it looks as if I will have to report less than stellar results. While our audits aren't complete yet, we have obtained evidence that some of the state agencies charged with administering the CARES Act funding didn't have plans in place to ensure the money would be spent according to the federal requirements.

Ordinarily, my office doesn't release the results of our audits until all the work is complete, but in this case, the legislators deserve to know how well North Carolina is doing BEFORE all the money is spent. OSA staff is working tirelessly to provide as much information about how this money is being managed as quickly as possible. Once the funds are out the door, there's not much that can be done.

As this will be the last issue of The Monitor for this year, I want to wish everyone a safe and happy holiday season. Please find safe ways to celebrate with friends and family, and hopefully 2021 will bring brighter days for all of us.
